**GENERAL TERMS & CONDITIONS**

This agreement with ALRABTA AL ARABIA is made on the date specified below between the person(s) and/or company(s) participating:

Here in after referred to as “Organizer” and “Exhibitor”. The Exhibitor undertakes to participate in the said exhibition and has applied to the Organizer for the right to occupy space on the terms hereinafter contained.

**EXHIBITOR:**

- This license to participate is personal to the Exhibitor and is not transferable. The Exhibitor shall not assign or sublet the stand space or any part thereof. In addition to the Exhibitor may not assign or transfer any of its right or obligation under this agreement without the prior approval or written consent of the organizer.
- The Exhibitor will not be allowed to take over their space unless payment terms specified on the application are fulfilled.
- Exhibitor's display shall be placed with the contracted space area and shall not in any manner obstruct or be offensive to other Exhibitors or visitors.
- The Exhibitor will be responsible for any damage to the walls or floors in their designated area.
- The Exhibitor will comply with all the rules and regulations of the authority having control over the building.
- The Exhibitor will keep clean and tidy the space occupied to the satisfaction of the Organizer.
- No electrical work will be undertaken by the Exhibitor without the consent of the Organizer and then, only by the electrical contractor approved by the Organizer.
- All Exhibitors' stands with display material above 2.4 meters must submit design plans to the Organizer for prior approval 2 months before event.
- All Exhibitors with open/raw space must submit design plans to the Organizer for approval 2 months prior to the event.
- All product and equipment must be insured by the Exhibitor.
- The Exhibitor must follow the operation schedule stated in the Exhibitors Manual. This will be issued 2 months prior to the Exhibition.
- Contracting parties for group stands are responsible for ensuring that all Exhibitors within their group are fully aware of and agree to abide by these Terms and Conditions and by the Rules and Regulations of the Exhibition.
- Any loss or damage to the basic fitted stand is the responsibility of out insurance for the purpose of covering himself against all risk in respect to which the Organizer is expressed to not be responsible.
- Sharing of space/stands to other participating Exhibitors or company is not allowed and strictly prohibited.

**ORGANIZER:**

- The Organizer reserves the right to refuse any application, cancel an agreement, relocate an Exhibitor's stand or amend the floor plan at its discretion with valid reason.
- The Organizer may reject, cause, and/or require any display or demonstration to be removed or stopped by an Exhibitor which in the opinion of the Organizer creates a disturbance, constitutes a nuisance, or is likely to lead to a prosecution of being offensive or otherwise unlawful.
- The Organizer is not responsible for any loss or damage to any product exhibited during live show timing.
- The Organizer shall not responsible for the loss of damage to any property of the Exhibitor or any other person caused by the theft, fire, defect in the Exhibition Center, tempest, national emergency civil unrest, war, labor disputes, lockouts, explosions, acts of God, general cause not within the Organizer's control; or of any loss or damage in the event that the opening of the holding of the Exhibition is prevented, postponed, or abandoned; or if the hall becomes totally or partially unavailable for the Exhibition due to any of the above stated causes.
- The Organizer cannot accept any complaint or claim against him/her unless it is submitted in writing to the address given below within 2 weeks of the closing date of the Exhibition. All claims, disputes shall be settled in Qatar in accordance Qatar Laws and Customs.
- In the event of a breach of any of the conditions herein, the Organizer may in all cases retain all payments paid by the Exhibitor and recover a further amount from the Exhibitor as provided herein.

**CANCELLATION POLICY**

In the event the Organizers agrees to any request for release from the agreement, the Exhibitor shall be liable for all of part of the costs stated in the Agreement, in accordance with the following scale:

- 50% of the total cost if the cancellation is less than 90 days prior to the Exhibition opening date.
- 75% of total cost if the cancellation is 60 days prior to the exhibition opening date.
- 100% of the total cost if the cancellation is 30 days or less before the exhibition opening date.

\*\*In order to receive a full refund you must give the Organizer notice ATLEAST 90 days prior to the exhibition/conference opening

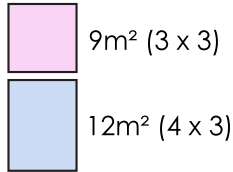

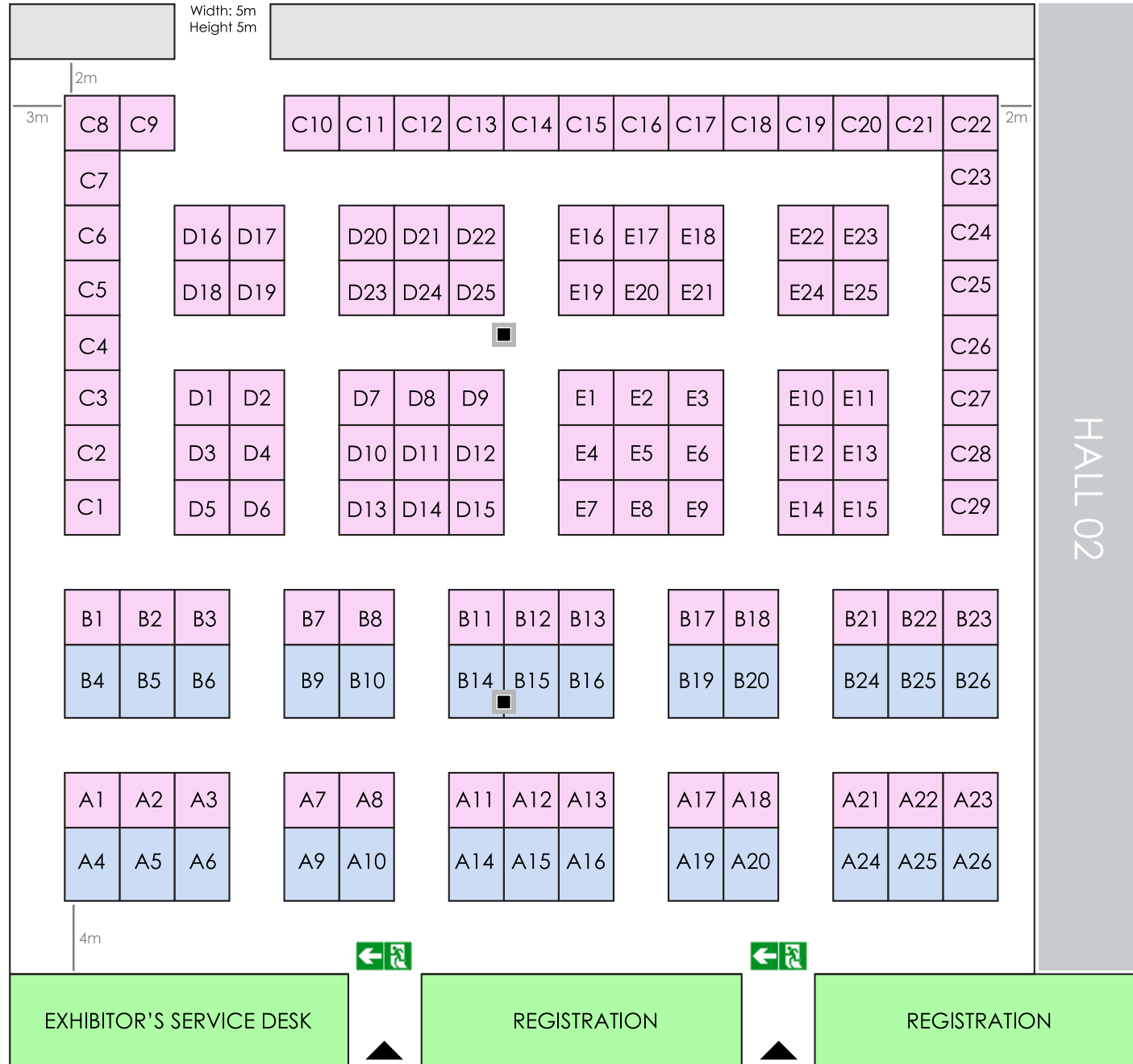
